#### **PREFACE**

- B Throughout this work, irrespective of the particular calendar in use at the time, the seasons of the year have been constituted as follows: Winter—January to March inclusive; Spring—April to June inclusive; Summer—July to September inclusive; and Autumn—October to December inclusive.
