

### Acknowledgments

This book began as a Ph.D. dissertation that was completed at the University of Illinois in October 1983. During the course of the dissertation and subsequent revisions, I benefited greatly from the help of a number of individuals, a few of whom I would like to single out. At Illinois, Larry Neal and Peter Schran, my Ph.D. supervisor, were very influential in the formative stages of this project. Shortly after the dissertation was completed, I received long letters from Ramon Myers, of the Hoover Institution, Stanford University, and Thomas Rawski, then of the University of Toronto, providing new inspiration and detailed comments for subsequent revisions. ## Weights and Measures

Except as noted, 1 picul equals 110 pounds; 20 piculs equal 1 metric ton; and 1 picul contains 100 chin or catties. A shih is a volume measure and in the case of grain equals approximately 160 catties. 1 shih equals 10 tou; 1 tou equals 10 sheng. 1 mou equals 0.1647 acre, which equals 0.0666 hectare. Six mou, therefore, equal 1 acre; 15 mou equal 1 hectare.
