

This study focusses on the way the Letter to the Hebrews explains the Christian doctrine of salvation by means of sacrificial symbols drawn from the Old Testament. Theories about the nature of sacrifice are taken from the work of social anthropologists to show the underlying meaning of these symbols and how they affect the meaning of this text

In relating New Testament studies to the methods of the social sciences, this book differs from most writings about Hebrews, which are either historical studies of the letter's background or theological studies of the author's ideas. Dr Dunnill assesses Hebrews, not as an argument, but as an act of symbolic communication; he thus aims to identify some of its underlying structures and reveal the source of its power.

PREFACE

This book is a revised version of a doctoral thesis presented to the University of Birmingham in 1988. The research was conducted under the supervision of David Ford, and the final product owes a great deal to his searching questions, his patience and his endless encouragement. I am also extremely grateful to Frances Young, from whose wise guidance I have benefited at several stages, and to Leslie Houlden, Andrew Chester and the former editor of this series, Graham Stanton, who read the original version and made helpful comments from which I have tried to learn in making this revision.

I wish to record also my thanks to David Ravens, who first directed me towards theological study, and whose comments on early versions of this book stimulated further thought; to Alan Browning and Philip Budd, for their friendship and encouragement of this project at different times; and most of all to my wife Maggie who, inheriting this as 'work in progress', has helped me to believe both that it was worth doing, and that it should be finished.
